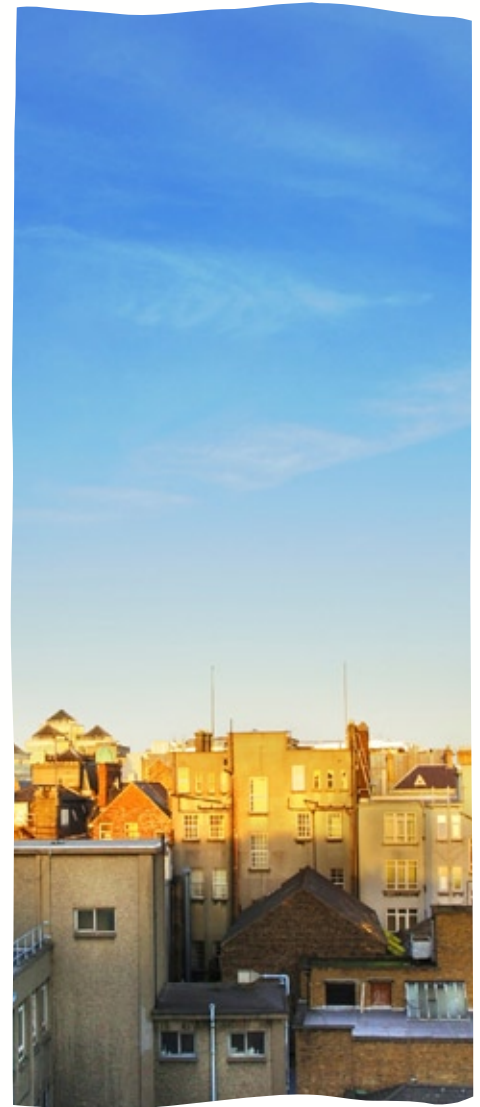
Guidelines & Briefings
